What information do we collect from you?

Why do we collect this information?

Personal information is collected to manage your consent.

Who might we share your information with?

How long do we keep hold of your information?

Veolia Environmental Trust / Veolia will retain video footage for no more than 6 years and still images for no more than 6 years. Personal details will be retained for as long as we retain either video or still images of you.

How can I access the information you hold about me?

You have the right to ask us for your personal information that we hold and process about you. This is known as a subject access request.

You can also request:

- that any inaccurate information we hold about you is corrected;
- that we delete information about you in certain situations;
- that we stop using your personal information for certain purposes;
- that we don't make decisions about you by completely automated means;
- that personal data you have given us be provided to you in a common machine readable format, or sent to a third party where this is technically feasible;
